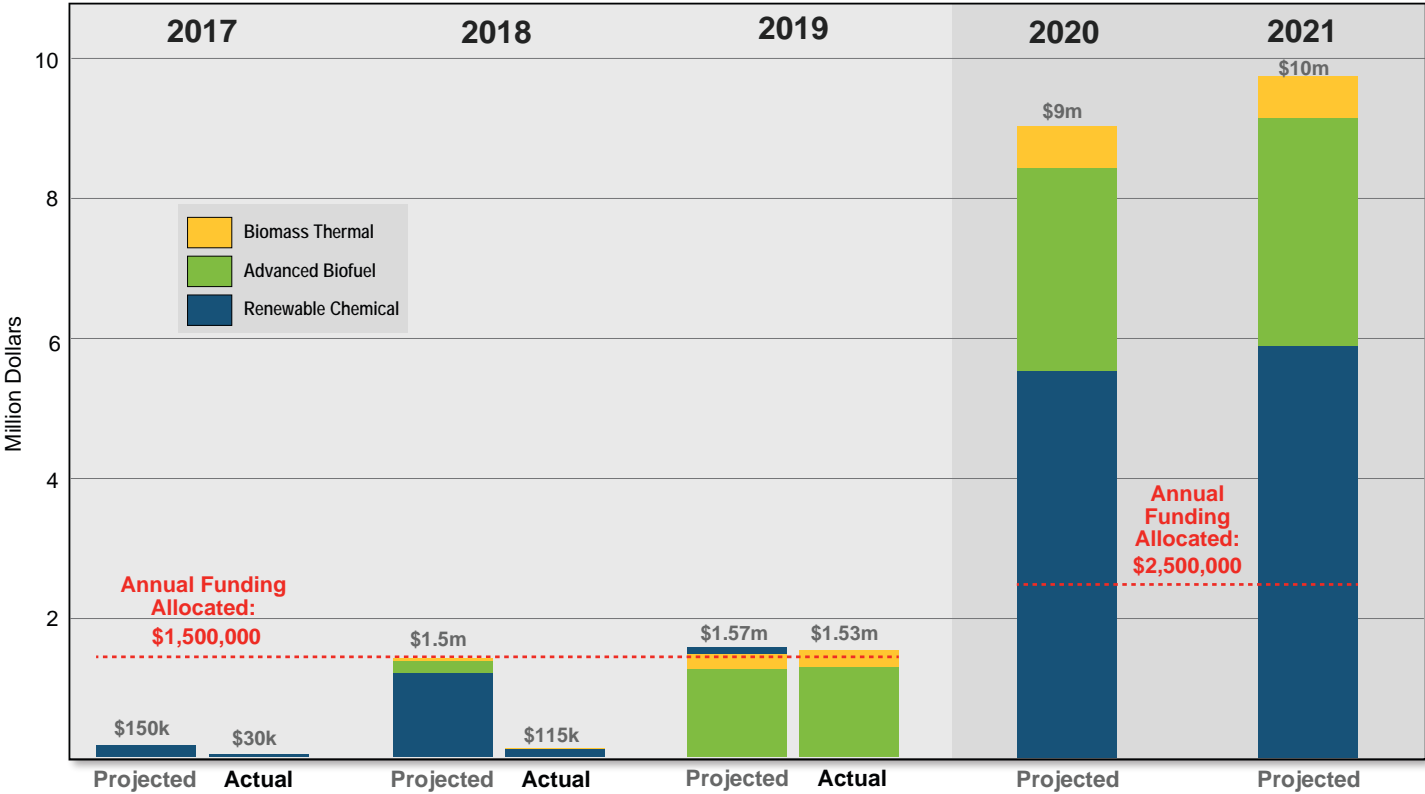

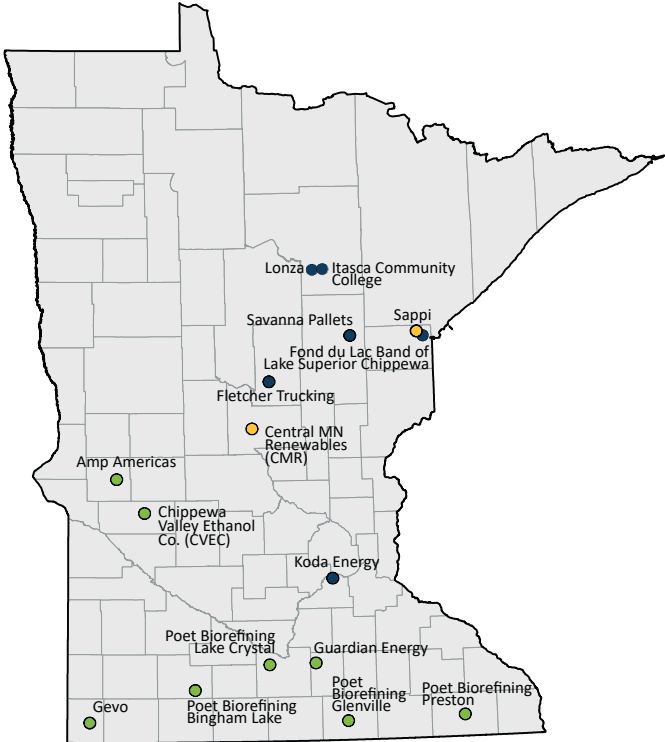
## MN Bioincentive Projections and Reimbursement
